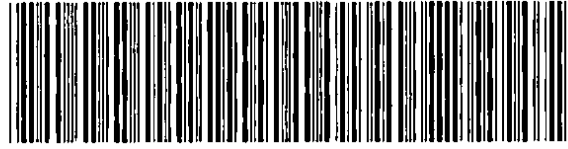


ARTICLE V. MANAGEMENT
