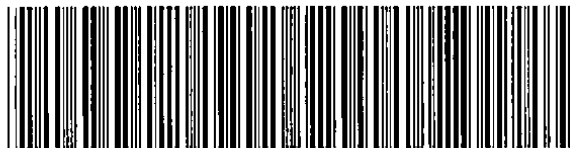



6. This conversion is effective under the laws governing the Florida Professional Limited Liability Company on December 4, 2024.






