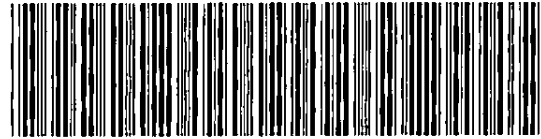

## ARTICLES OF ORGANIZATION


#### **ARTICLE IX - MANAGEMENT**

#### **ARTICLE X - AMENDMENT**

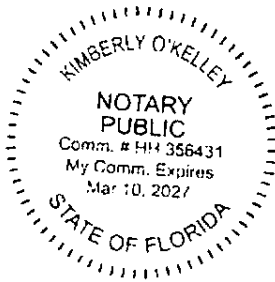

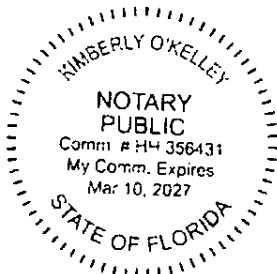
