**ARTICLES OF ORGANIZATION  
OF

**ARTICLE I - NAME**


**ARTICLE III - CERTIFICATE OF DESIGNATION OF

#### ARTICLE VI - ADMISSION OF ADDITIONAL MEMBERS


