

ARTICLES OF ORGANIZATION OF CATES HOLDINGS, LLC

ARTICLE I

Name and Principal Place of Business

The name of this limited liability company is CATES HOLDINGS, LLC; the physical address of its principal office is 3405 Pine Top Drive, Valrico, Florida 33594, and its mailing address is 3405 Pine Top Drive, Valrico, Florida 33594.

ARTICLE II Purposes
