ARTICLE VII - ADMISSION OF ADDITIONAL MEMBERS



ARTICLE IX - EFFECTIVE DATE


Pursuant to the provisions of Chapter 605, Florida Statutes, this limited liability company shall begin in existence on **January 2, 2025**.
