ARTICLES OF ORGANIZATION OF TOP TIER INSTRUCTION, LLC

The undersigned, acting as an authorized representative of the initial members of the above captioned Limited Liability Company, under the provisions of the Florida Revised Limited Liability Company Act, Chapter 605, *Florida Statutes*, adopts the following Articles of Organization:

ARTICLE I NAME & ADDRESS

The name of this limited liability company shall be **TOP TIER INSTRUCTION**, **LLC** (the "Company"), and its principal office and mailing address is 13204 Saw Palm Creek Trail, Bradenton, Florida 34211.

ARTICLE II EFFECTIVE DATE
