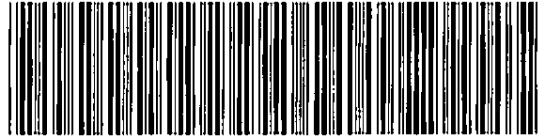



ARTICLES OF ORGANIZATION

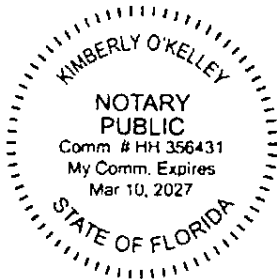



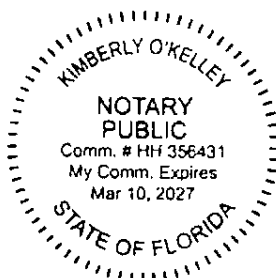
