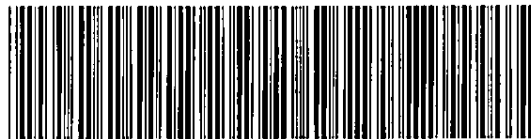



## ARTICLES OF ORGANIZATION

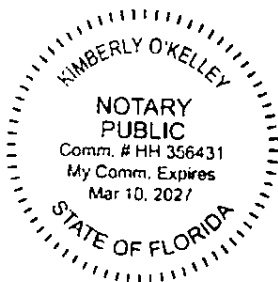

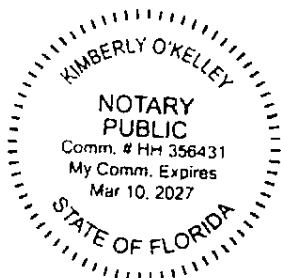
