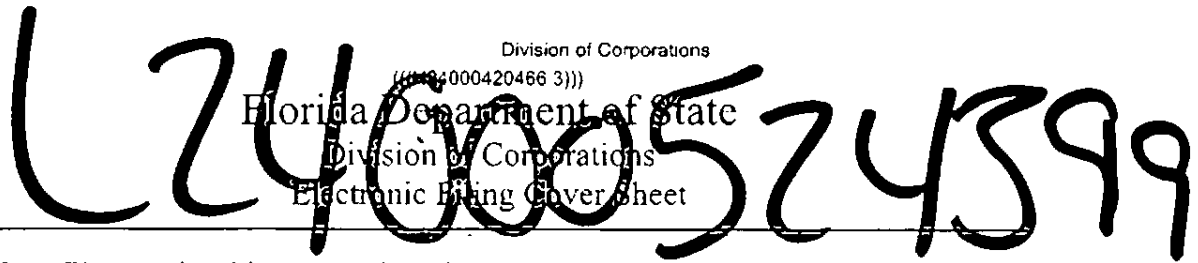

The initial address of the principal office and the mailing address of the Company is 201 West Ponce de Leon Avenue #418, Decatur, Georgia 30030."

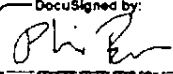
4. Except as amended hereby, the Articles of Organization of the Company shall remain in full force and effect.

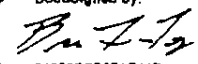
