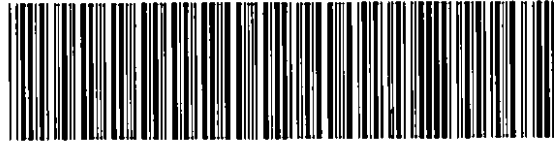



**Articles of Conversion
For
Florida Profit Corporation

Florida Limited Liability Company**

This Articles of Conversion and attached Articles of Organization are submitted in accordance with ss. 607.11930 – 607.11935, Florida Statutes, to convert the following Florida Profit Corporation into an **“Other Business Entity”, a Florida Limited Liability Company.**

1. The name of the Florida Profit Corporation immediately prior to the filing of these Articles of Conversion is **Central Florida Lumber and Supply Co.**
2. The Florida Profit Corporation is a corporation organized, formed or incorporated under the laws of the State of Florida on **June 22, 1933 (Document #127770).**
3. The jurisdiction of the Florida Profit Corporation has not changed since its formation and this conversion hereby complies with the applicable laws governing the “Other Business Entity”. The name of the Florida Limited Liability Company is **Mills & Nebraska, LLC**.




