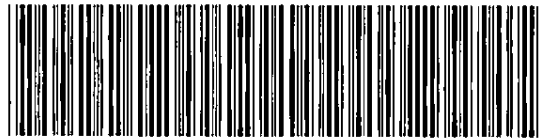

ARTICLE VII: Capital Contributions

Each member shall make an initial capital contribution as agreed upon. Contributions may be in cash, property, or services rendered. The initial capital contributions are as follows:

1. **Veritas Health Ministries Trust** (through Trustee): \$[11,000.00]
2. **The Tree of Life Ministries** (through Trustee): \$[10.00]

ARTICLE VIII: Membership Interest

These Articles of Organization may be amended by a majority vote of the membership interests or as specified in the LLC's Operating Agreement and in accordance with **Florida** law.

ARTICLE XIII: Operating Agreement

The Operating Agreement for **CK Veritas Consulting LLC** shall cover the following aspects:

1. **Profit Distribution:** Profits shall be distributed to the members annually or as otherwise determined, based on available funds and at the members discretion.
2. **Voting Rights:** Voting rights are proportional to each member ownership percentage, unless otherwise specified in the Operating Agreement.
