**ARTICLES OF ORGANIZATION
OF
EASYDWELL 14, LLC**

The undersigned, being the sole member, desiring to form a limited liability company under and pursuant to the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes, does hereby adopt the following Articles of Organization:

**ARTICLE I
NAME**

The name of the limited liability company is EasyDwell 14, LLC (the "Company").

**ARTICLE II
ADDRESS**

The Company is authorized to issue One Thousand (1,000) membership units.

MANAGEMENT

The business of the Company shall be conducted, carried on, and managed by at least one (1) Manager and is, therefore, a manager-managed Company. The Manager(s) shall serve in such capacity until his, her, or their successor(s) is/are duly elected and qualified.

OPERATING AGREEMENT




