ARTICLES OF
OF
INCORPORATION

ARTICLE I - NAME

The name of this corporation is TRC HOME SERVICE, INC.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the day these Articles become effective by approval by the Florida Department of State, Division of Corporations.

ARTICLE III - PURPOSE

This corporation is authorized to transact any lawful business for which corporations may be formed under Chapter 607, Florida Statutes.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue 1,000 shares of common stock with a par value of \$1.00 per share which shall be designated as common shares.

ARTICLE V - PREEMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his prorata share thereof (as nearly as may be done without issuance

of fractional shares) at the price at which it is offered to others.

ARTICLE VI - INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of this corporation is 111 Southeast First Avenue, Gainesville, Florida 32601, and the name of the initial registered agent of this corporation is Robert E. Roundtree, Jr., 111 Southeast First Avenue, Gainesville, Florida 32601.

ARTICLE VII - BY-LAWS

The power to adopt, alter, amend or repeal By-Laws shall be vested in the Board of Directors and the shareholders.

ARTICLE VIII - RESTRICTIONS ON TRANSFER

Shares held by the initial shareholders may not be resold or otherwise transferred to other persons unless such shares are first offered to the remaining shareholders or to this corporation. The price and terms at which, and the time within which, such shares may be offered and sold shall be further specified by written agreement among all of the initial shareholders and this corporation.

ARTICLE IX - NO CUMULATIVE VOTING

At each election for directors, every shareholder is entitled to one vote for each share of stock held and cumulative voting shall not be permitted.

ARTICLE X - CALLING OF SPECIAL MEETINGS

Special meetings of shareholders may be called by holders of ten per cent (10%) of issued stock.

ARTICLE XI - SHAREHOLDER QUORUM AND VOTING

Fifty-one per cent (51%) of the shares entitled to vote, represented in person or by proxy, shall constitute a quorum at a meeting of the stockholders.

If a quorum is present, the affirmative vote of fifty-one per cent (51%) of the shares represented at the meeting and entitled to vote on the subject matter shall be the act of the shareholders.

ARTICLE XII - POWERS

This corporation shall have all of the corporate powers enumerated in the Florida Corporation Act, including the power to be a promoter, incorporator, partner, member, associate or manager of any corporation, partnership, joint venture, trust or other enterprise.

ARTICLE XIII - DIRECTORS

Directors of this corporation need not be residents of Florida. The shareholders of this corporation shall have exclusive authority to fix the compensation of the directors. There shall always be a minimum of one director.

ARTICLE XIV - OFFICERS

The officers of this corporation shall consist of a President, Vice President, Secretary and Treasurer each of whom shall be elected by the Directors. Any two or more offices may be held by the same person.

ARTICLE XV - INDEMNIFICATION

The corporation shall indemnify any officer or director or any former officer or director, to the full extent permitted by law.

ARTICLE XVI - AMENDMENT

This corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation, or any amendment thereto, and any right conferred upon the shareholders is subject to this reservation.

ARTICLE XVII - INCORPORATOR

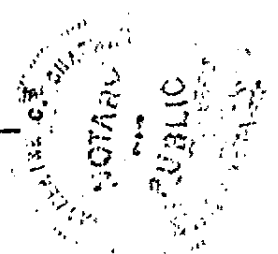
