ARTICLES OF ORGANIZATION OF T3 ST. AUGUSTINE STORE, LLC

These Articles of Organization are made for the purpose of organizing a Florida Limited Liability Company under the Florida Limited Liability Company Act (Florida Statutes Chapter 608).
