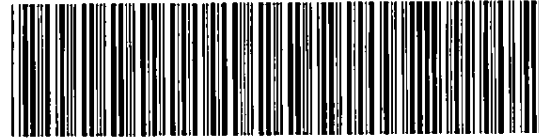

7. The effective date of Conversion to a Florida Limited Liability Company is upon filing.

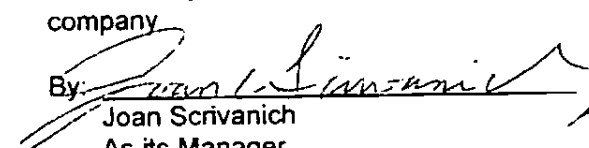
