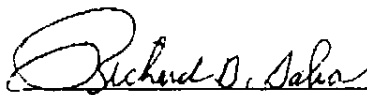

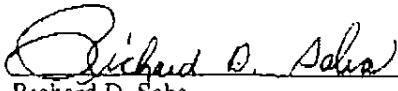
ARTICLE V
