**ARTICLES OF ORGANIZATION
OF
STM STRATEGIES, LLC,
a Florida limited liability company**

The undersigned, acting as the Manager of STM Strategies, LLC (the "Company"), does hereby certify that said Manager has formed the Company to be a limited liability company under the laws of the State of Florida and under the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes, as amended (the "Act"), and, pursuant to the Act, hereby sets forth the following Articles of Organization:

ARTICLE I: NAME

The name of the Company shall be **STM Strategies, LLC**.

ARTICLE II: ADDRESS AND PLACE OF BUSINESS

The initial address of the principal office and the mailing address of the Company shall be 1100 S Miami Avenue, Unit 1901, Miami, Florida 33130.

ARTICLE III: DURATION AND PURPOSE

The period of duration of the Company shall be perpetual. The Company is formed for the purpose of conducting and undertaking, and shall have the power to conduct and undertake, any and all activities and actions authorized under the Act.

ARTICLE IV: MANAGEMENT

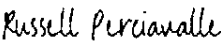

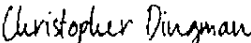
