**Articles of Organization  
of  
Venice Vision, LLC**

(A Florida Limited Liability Company)

The undersigned organizer hereby adopts these Articles of Organization for the purpose of forming a Limited Liability Company under The Florida Limited Liability Company Act, Chapter 605 of the Florida Statutes (the "Act").

1. **NAME.** The name of this limited liability company (the "Company") is **Venice Vision, LLC.**

2. **EFFECTIVE DATE AND DURATION.** The existence of the Company shall commence on January 22, 2025. The period of duration of the Company shall be perpetual.

3. **PURPOSE.** The purpose and business of the Company shall be to engage in any lawful act or activity which may be carried on by a limited liability company under the Act. However, the Company entity shall not engage in any business activity other than that which is directly related to the operation of a Pearle Vision retail optical or such other business operation as shall be approved in writing by Luxottica of America Inc., Franchise of Pearle Vision. ("Pearle Vision").

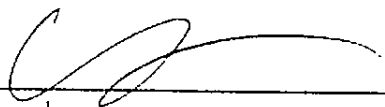

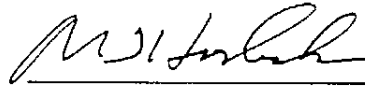
