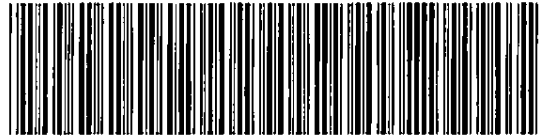

### **ARTICLE I – Name:**

The name of the Limited Liability Company is **Elite HH SWFL LLC**.
