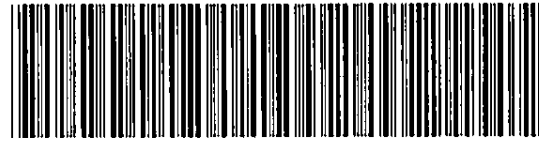

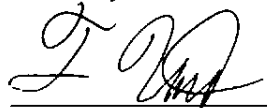

Management

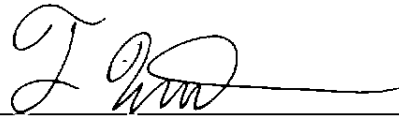
