ARTICLE V

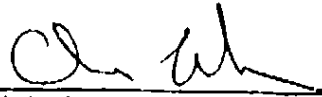

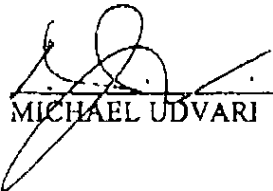
