ARTICLES OF ORGANIZATION OF SUNNY SEASIDE INVESTMENT LLC

The undersigned, being a duly authorized representative of the Member, desiring to form a limited liability company under and pursuant to the Florida Limited Liability Company Act. Chapter 605, Florida Statutes (the "Act"), does hereby adopt the following Articles of Organization:

ARTICLE I. NAME

The name of the limited liability company is Sunny Seaside Investment LLCE (the "Company").

ARTICLE II. ADDRESS

The principal and mailing address of the Company is 81 Sidecamp Road, Inlet Beach, Elorida 32461.

ARTICLE III. REGISTERED AGENT AND OFFICE
