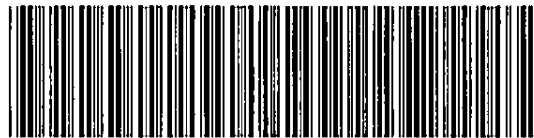

**ARTICLES OF AMENDMENT TO ARTICLES OF ORGANIZATION
OF
SUNNY SEASIDE INVESTMENT LLC**

Pursuant to the provisions of the Florida Limited Liability Company Act, Chapter 605, Florida Statutes, **Sunny Seaside Investment LLC**, a Florida limited liability company (hereinafter, the "Company"), adopts the following Articles of Amendment to its Articles of Organization:

FIRST: The Articles of Organization of **Sunny Seaside Investment LLC** were filed with the Florida Department of State on March 3, 2025 and assigned document number L25000090314.

SECOND: The Company's Articles of Organization are hereby amended by deleting Article II of the Articles of Organization in its entirety, and replacing it with the following new Article II:

"ARTICLE II. ADDRESS"

The principal address of the Company is 201 E. Ruskin Place, Santa Rosa Beach, Florida 32459. The mailing address of the Company is PO Box 4693, Santa Rosa Beach, Florida 32459."

THIRD: The Company's Articles of Organization are hereby amended by deleting Article III of the Articles of Organization in its entirety, and replacing it with the following new Article III:

"ARTICLE III. REGISTERED AGENT AND OFFICE"

The Company designates 201 E. Ruskin Place, Santa Rosa Beach, Florida 32459 as the street address of the registered office of the Company and names KaraLynn M. Saab as the Company's initial registered agent at that address to accept service of process within this state."

FOURTH: The Company's Articles of Organization are hereby amended by deleting Article V of the Articles of Organization in its entirety, and replacing it with the following new Article V:

"ARTICLE V. MANAGEMENT"

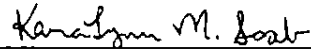
The Company shall be conducted, carried on, and managed by at least one (1) Manager and is, therefore, a manager-managed Company. The name and address of the person authorized to manage and control the Company are:

FIFTH: Except as expressly provided herein, all of the terms and provisions of the Articles of Organization shall remain in full force and effect and are hereby ratified and confirmed.
