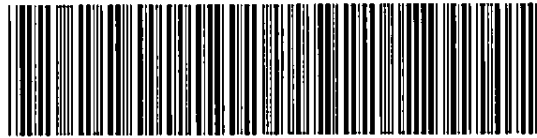

The name of the Limited Liability Company is: **SDW Family Holdings, LLC** (the "**Company**").

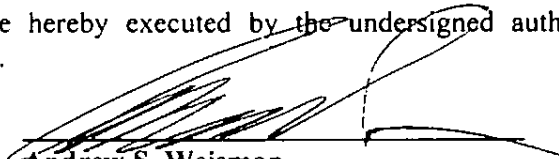

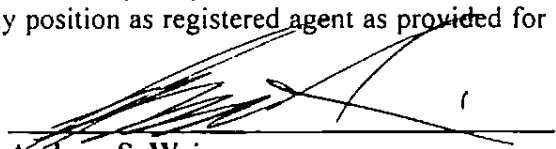
