**ARTICLES OF ORGANIZATION

The undersigned, Jeremiah Christopher, a natural person competent to contract and an authorized representative of Sea Sweet Capital, LLC, hereby presents these Articles of Organization as the Articles of Organization of Sea Sweet Capital, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I - NAME

The name of the limited liability company is Sea Sweet Capital, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

ARTICLE II - PRINCIPAL OFFICE ADDRESS
