**Articles of Organization for PHOENIX TACTICS, LLC
a Florida Limited Liability Company (FS 608.407)**

The undersigned, desiring to form a limited liability company under and pursuant to Florida Statute 608, entitled the Florida Limited Liability Company Act, does hereby adopt the following Articles of Organization for such company:

ARTICLE I – NAME

The name of this Company shall be PHOENIX TACTICS, LLC

ARTICLE II – PURPOSE

This Company is formed in order to operate a retail, manufacturing or security business. In addition, the Company shall be authorized to undertake any lawful business or enterprise allowed by the Laws of the State of Florida and of the United States.

ARTICLE III – INITIAL PRINCIPAL OFFICE, MAILING ADDRESS
AND INITIAL REGISTERED AGENT

ARTICLE VII – RIGHT TO CONTINUE BUSINESS

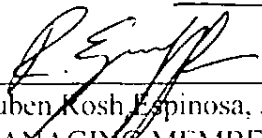
ARTICLE VIII - MANAGEMENT

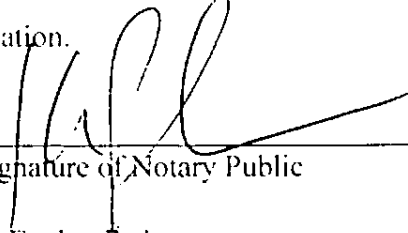

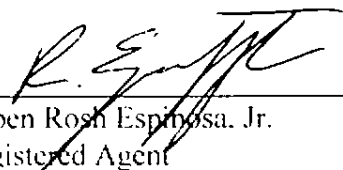
