

ARTICLES OF ORGANIZATION OF JJP VENTURES, LLC

Pursuant to §605.0201 of the Florida Revised Limited Limited Company Act, Florida Statutes, as amended from time to time (the "Act"), the following are adopted as the Articles of Organization of the limited liability company organized hereby:

ARTICLE I NAME
