DURATION**

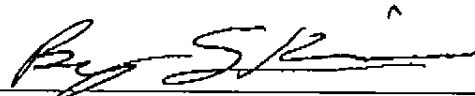
The Company's existence shall commence on May 13, 2025, and it shall exist perpetually thereafter unless dissolved according to law or the Company's Operating Agreement.

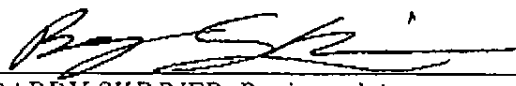
