The Limited Liability Company is to be Manager managed and the name and **corrected address** of the initial Manager is:

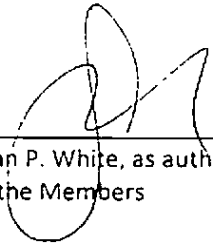
