

7991 West Lake Drive, West Palm Beach, FL 33406 is owned by Marcia Witt and is the homestead residence of Marcia Witt. Sonya Witt does not reside at 7991 West Lake Drive, West Palm Beach, FL 33406, and she has not resided at 7991 West Lake Drive for decades.
