ARTICLE IV

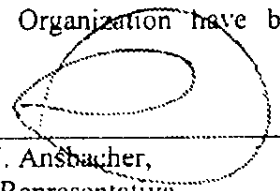

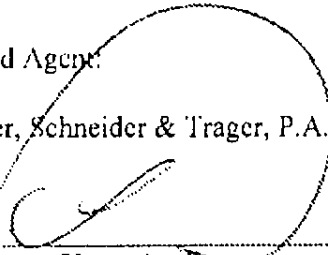
