ARTICLE I
NAME

The name of the limited liability company shall be **15610 YR HOLDINGS, LLC** (the "Company").

ARTICLE II
MAILING ADDRESS

ARTICLE III

**ARTICLE VI
STREET ADDRESS OF PRINCIPAL OFFICE**

The street address of the principal office of the Company shall be located at 10461 SW 64 Street, Miami, Florida 33173, but it shall have the power and authority to establish branch offices at any other place or places as the Members may designate.

**ARTICLE VII
