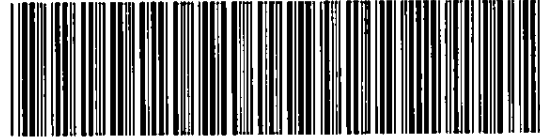

Articles of Organization

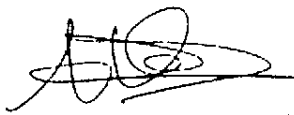
