ARTICLE V. INDEMNIFICATION

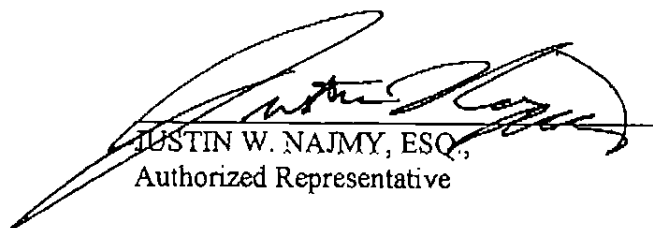

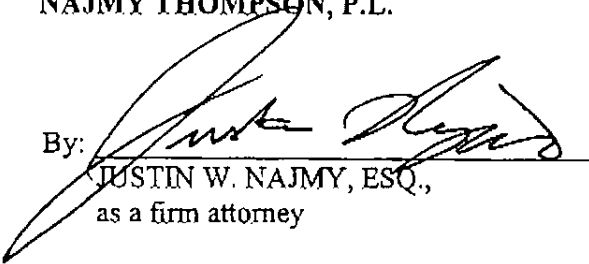
