To Whom It May Concern:

We are enclosing a check for \$ 165.00 payable to the Florida Department of State in payment of our Annual Corporation Reporting Fee. We are asking that the penalty for late filing be abated due to the following set of circumstances.

1. The annual report is mailed to our attorney who is supposed to inform us when the paperwork has arrived and what we are to do with it.
2. The attorney named on the report is our Registered Agent.
3. We never received the original paper work nor did we receive the first notice (if one was sent) that we were late.
4. When our attorney sent us the current notice, we called to see why they had not sent us any previous paperwork or notices.
5. Although they have no written record of mailing us the original and first notice, they assured us that they must have sent it because they do not have it.

As far as we know, the current notice of late filing is the first thing that we have received concerning filing for 1997. We feel that \$ 385.00 in penalties for a \$ 165.00 fee is exorbitant to begin with. And, considering the fact that we never received any notices from you until now, we ask for your consideration in eliminating the penalty altogether.
