**ARTICLES OF ORGANIZATION

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 605, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE 1. NAME.

ARTICLE 6. REGISTERED OFFICE AND REGISTERED AGENT.

The Company shall continue until dissolved in accordance with the Operating Agreement of the Company or applicable law. The death, retirement, resignation, expulsion, bankruptcy, or dissolution of a Member shall not automatically cause the dissolution of the Company. The Company may continue its business in accordance with the Operating Agreement. The disposition of a deceased Member's Membership Interest, including any Transfer on Death designation if authorized by the Operating Agreement, shall be governed by the terms of the Operating Agreement and applicable law. If no such designation exists, the Membership Interest shall be handled in accordance with the Operating Agreement.

ARTICLE 9. MANAGEMENT.

The Company shall be managed by one or more managers in accordance with an operating agreement adopted by the members for the management of the business and affairs of the Company. The operating agreement may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with law or these Articles of Organization.
