Article I

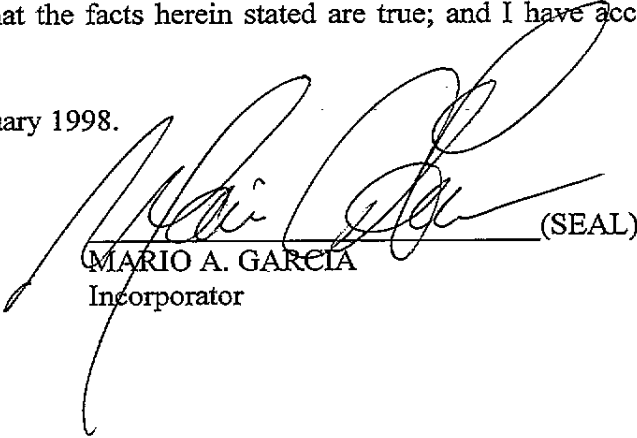
Name, Principal Place of Business and Duration
