**ARTICLES OF AMENDMENT  
TO THE ARTICLES OF INCORPORATION**

**DISPOSALL, INC. OF VOLUSIA**

a Florida corporation

Pursuant to Sections 607.1001, 607.1003 and 607.1006 of the Florida Statutes, **DISPOSALL, INC. OF VOLUSIA**, a Florida corporation (the "Corporation"), hereby adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the corporation is **DISPOSALL, INC. OF VOLUSIA**.
2. Article I of the Corporation's Articles of Incorporation is hereby amended in its entirety as follows:

**ARTICLE I**

Name

The name of the corporation shall be **DISPOSALL, INC. OF PASCO**.

3. The aforesaid Amendment to the Articles of Incorporation of **DISPOSALL, INC. OF VOLUSIA**, was adopted and approved by an action by written consent of the sole director and shareholder of the Corporation on the 31<sup>st</sup> day of January, 2000, with the unanimous vote of the sole director and all votes of the shares of stock of the Corporation being voted in favor of such Amendment.
