TO WHOM IT MAY CONCERN:


The principal behind subject corporations, Mr. Ulf G. Tenne, contacted us from Sweden some time ago asking us if we could find out why he had received notices that his corporations were subject to administrative dissolution. He had just found out that the requested Certificates of Status had not been received and that his two checks sent with his Annual Reports had not been cashed by his bank. He had tried to contact your office through an 800-number, but apparently it could not be connected from Sweden.

We do not want to bore you with a lengthy recital of what Mr. Tenne has suffered since taking on an assignment a year ago to coordinate and promote trade activities between the European Union countries and the North and Latin Americas. Suffice it to say that based in Stockholm, shortly after arriving there he fell severely ill with double sided pneumonia, with hospital stays and invasive pneumothorax surgery following. In one short recuperative time he made sure to send in (on Feb 26, 2004) his two annual reports, also requesting certificates of status. He mailed them to 409 E. Gaines Street, Tallahassee, as he had previously sent some reports by courier. Somehow this mail must have gone astray.

As Mr. Tenne asked us to serve as his Registered Agent, we prepared the enclosed Corporation Reinstatement forms for his signature. We advised him to issue two replacement checks for the ones issued before and that in submitting them we would contact you to see whether reinstatement could be effected without the penalties normally assessed. As you note, the only reason for the annual reports not being in your office in time for normal filing is because of a mail delivery problem, just as if the forms had not been delivered to him in the first place.

We humbly pray for your kind understanding and consideration.
