In the past I have received a 9"x12" green UBR form which has reminded me of my need to file. This year, I have no record of having ever received any correspondence from your offices. Had I received the forms, I surely would have filed timely.

Per instructions from your office I have downloaded a copy of the form online and am immediately remitting it with payment. I have a small family owned business and am compliant with the IRS and Florida Department of Revenue in regards to all tax filings and payments. This has been a difficult year for me as I am almost 79 years old and was in a major car accident in October of 2003. Since then, I have been in and out of the hospital with complications. Accordingly, my office time has been limited.

I understand the need to have enforcement and compliance penalties, but feel that it is not warranted in this case. Such an added penalty would be an unbearable burden to my companies as it is the sole support for my family and cannot afford large unexpected expenses including these penalties.

I appreciate your kind assistance in this regard and you have my assurance that I am now aware of the state's new filing procedures.
