Enclosed is the 2002 Uniform Business Report for Naples Welding Service, Inc. and our check for \$150.00. We are requesting a waiver of the late fee because the principal of Naples Welding Service, Inc. died on December 28, 2001 and the personal representative of the Estate of Richard J. Simecek was unfamiliar with the State's requirements.

Prior to his death, Richard J. Simecek handled all of the reporting requirements for his corporation while the financial reporting was handled by Mr. Simecek's CPA. After his death, the personal representative of the Estate of Richard J. Simecek located the 2002 Uniform Business Report (2002 UBR) in Mr. Simecek's mail and took it to the CPA. The CPA informed her that the report was for the year 2002 and since Mr. Simecek was dead, the 2002 UBR should not be completed because Mr. Simecek would not be operating the business in 2002 having died at the end of 2001. Since the personal representative was unfamiliar with the UBR, she accepted the CPA's explanation. When the second 2002 UBR arrived in the mail in July 2002, the personal representative contacted the Division of Corporations to inform you that Mr. Simecek had died and provide what ever documentation you required. It was at this point that the 2002 UBR was explained to the personal representative and she realized it needed submit. During the conversation, the personal representative was informed that the \$400.00 late filing fee would be waived.

On or about July 29, 2002, the personal representative informed me of the status of the 2002 UBR. She stated that she had not filed the 2002 UBR when the first form arrived because the CPA told her the form applied to Mr. Simecek's operation of the business during 2002, which was impossible as a result of his death. The personal representative also informed me of her conversation with your division and the possibility of waiving the \$400.00 late fee.

The 2002 UBR has now been completed to reflect the new management structure of Naples Welding Service, Inc. Mr. Edwin Theodore Roth III was not part of Naples Welding Service, Inc. prior to Mr. Simecek's death and was unaware of the 2002 UBR prior to executing it on July 29, 2002.

Because the failure to file timely was the result of the death of the principal and incorrect advice given to the personal representative who knew nothing about a UBR form, we are requesting that the \$400.00 late fee be waived and the payment of \$150.00 be accepted.
