Pursuant to the provisions of Section 607.1006, Florida Statutes, Meininger & Meininger, P.A. (the "Corporation"), hereby adopts the following Articles of Amendment to its Restated Articles of Incorporation filed with the Florida Secretary of State on September 30, 1991 (the "Restated Articles"):

Article I - Amendments
