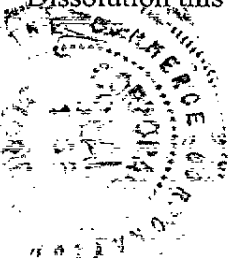

PURSUANT TO Chapter 607.1403, Florida Statutes, this Florida profit corporation submits the following articles of dissolution:


- FIRST: The name of this corporation is THE COMMERCE CORPORATION.
