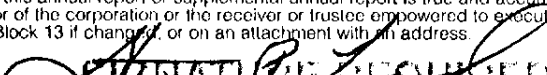

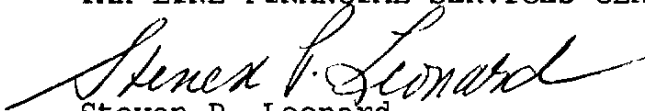
Gentlemen:
