MINUTES OF THE SPECIAL MEETING OF THE BOARD & STOCKHOLDERS

OF

QUICK CASH OF PANAMA CITY, INC.

A special meeting of the Board and Stockholders of the corporation was held at the companys' offices on December 15, 1996 at 1:00 pm.

The following directors and stockholders were present: David N. Ring. being the sole director and stockholder.

Mr. Ring presented and read a wavier of notice of the meeting, a copy of which is attached.

Mr. Ring then stated that the purpose of the meeting was to discuss methods by which his affiliated companies might operate more efficiently.

It was decided that it would be best to operate each corporation by state. That is, each affiliated corporate entity would operate offices of one particular state rather having offices from several different states within the entity. By doing this Mr. Ring could eliminate at least three corporate filings and could direct management resources more efficiently.

In order to achieve the above operating structure it was decided that Quick Cash of Panama City would transfer all of it's Georgia assets to Speedee Cash of Valdosta, Inc., an affiliated company, in exchange for cash at book value and would transfer all of it's Florida assets to Appliance and TV Rentals, Inc., also an affiliated company, for cash at book value. At the same time, in order to move the Alabama operations into an entity alone, Appliance and TV Rentals, Inc. is to transfer all of its Alabama assets to Quick Cash of Panama City, Inc., for cash at book value. There after Quick Cash of Panama City, Inc. is to change its name to SPEEDEE CASH OF ALABAMA, INC.

The above transfers are to be affected on December 31, 1996 after the close of business of each entity involved. All fillings needed to inform the state of Florida of the above changes are to be made.

Mr. Ring being the sole director and stockholder of the company made a motion and seconded it that the transfers be made.

There being no further business before the board and stockholders, on motion made, seconded and carried, the meeting was adjourned.
