**ARTICLES OF AMENDMENT
TO
ARTICLES OF INCORPORATION
OF
BRITE LITE SIGNS, INC.**

Pursuant to the provisions of Section 607.1006, Florida Statutes, **BRITE LITE SIGNS, INC.**, a Florida corporation (the "Corporation"), adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the Corporation is **BRITE LITE SIGNS, INC.**
2. The Articles of Incorporation were filed on December 15, 1989 and assigned document number L37064.
3. Article I of the Articles of Incorporation of the Corporation is hereby amended in its entirety to read as follows:


"ARTICLE I

NAME

Section 1.1 Name. The name of this corporation is **MOORE INVESTMENT HOLDINGS, INC.**"

4. The foregoing amendment was adopted by written consent of the Board of Directors of the Corporation without shareholder action and shareholder action was not required.
