

Dear Division of Corporations Person:

I have enclosed three (3) 2000 UBRs with checks for the "on time" amount due of \$150.00. I am asking that you consider my situation and to rule that the attached checks are acceptable for this late filing.

Simply stated, the three companies above listed, for which I am the one and only accounting/administrative person, had a confluence of two key occurrences that caused the filing (an accounts payable listing) to not occur:

Firstly, all three companies moved to the newly indicated address (see the three UBRs) and, for which, we had a terrible, terrible time getting our mail for almost one whole month. From a business point-of-view, it has continued to cost us dearly now witnessed by another botched situation--; that is, not having received the UBR forms.

Secondly, on top of the above commotion, I fell ill for nearly eight weeks which, then, required the companies to hire part-time accounting personnel for which there was little accountability.
