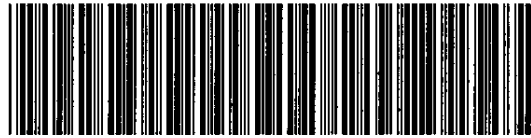

In connection with the dissolution of the above corporations, we have enclosed the following:


