1. Article I of this Corporation's Articles of Incorporation is hereby amended to read as follows:

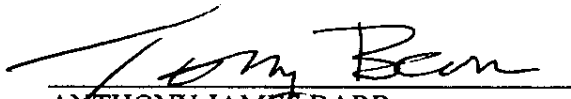

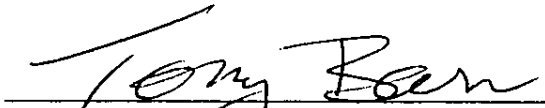
